D'Antay Freedman lives in Oakland, CA and is currently a sixth grader and member of the Oakland Boys and Girls Club, where he's known for his positive, can-do attitude, as well as his ability to settle disputes between his peers. D'Antay is a huge WWE fan, and says he uses WWE programming as an example of how to persevere in tough situations.
