

Seth Green to Host Monday Night Raw®

STAMFORD, Conn.--(BUSINESS WIRE)-- Actor/writer/co-executive producer and co-creator of the Emmy-winning Robot Chicken on Cartoon Network's Adult Swim, Seth Green will be the first celebrity guest host of Monday Night Raw. Green will take control this Monday, July 13, at 9pm/ET on USA Network.

WWE Superstar Triple H will be part of a sketch in Robot Chicken's season 4.5 premiere on Sunday, July 26 at 11:30pm/ET on Cartoon Network's Adult Swim with a sneak preview exclusively on Monday Night Raw.
